CET Call 2023 - Call Modules Eligibility Criteria

- Applicants must choose and apply to a specific call module when submitting their project proposal
- Evaluation and ranking of the project proposals will be performed separately per Call module

Does my organisation (provider of funding) consider all Call Modules as eligible?

International prerequisites – Call Module Specific Requirements

- Project Consortium Who Can Apply?
- Thematic Scope are there any further requirements?
- Targeted Technology Readiness Level (TRL)
- Additional Documents/Plans





CET Call 2023 - Other Transnational eligibility criteria

- Each project proposal must include at least three independent legal entities from at least three different countries participating in the CET Partnership Joint Call 2023, out of which at least two must be EU Member States or Horizon Europe Associated Countries.
- The total effort of one partner **cannot exceed 60** % of the total project efforts (measured in person months).
- The total effort of partners from one country/region **cannot exceed 75** % of the total project efforts (measured in person months).
- Project proposals must be written in English and submitted to the CET Partnership Submission Platform before the deadline (following mandatory proposal templates).

Project Duration

- Projects are required to start before 15 December 2024.
- The maximum project duration **must not exceed 36 months**.

CET Call 2023 - Evaluation & Selection

International Part (2-stages)

Stage 1

Submission of a **pre-proposal**: a project consortium chooses one Call Module for the pre-proposal. If the pre-proposal is selected, the project consortium is invited to submit a full proposal.

Stage 2

Submission of a **full proposal**, only if the preproposal is invited to participate in Stage 2.

National/Regional Part

All project partners will be evaluated according to national/regional eligibility criteria and requirements.

Some Funding Agencies require submission of a proposal on national/regional level. See the respective national/regional requirements for more information.

Call structure

Transnational Part (2 Stages)

Stage 1: Pre-proposal

Submission of a pre-proposal, including a concise project description as well as a description of the partners. If the pre-proposal is selected, the project consortium is invited to submit a full proposal.

Stage 2: Full proposal

Submission of a full proposal, only if the preproposal is invited to participate in Stage 2.


National/Regional Part

- All project partners will be evaluated according to national/regional eligibility criteria and requirements.
- Important! Some Funding Agencies require submission of a proposal on national/regional level. See the respective national/regional requirements for more information.

Who can apply

Research organisations: Higher education institutions including universities, university colleges; research institutes or other entities with research undertakings;

Urban government authorities such as regional and local government institutions, municipalities and municipal organisations, city authorities, urban public administrations, and infrastructure and service providers;

Companies and commercial organisations;

From the culture and creative sectors, e.g., artists and designers

Consumers and civil society representatives

such as local and community organisations, non-governmental organisations, not-for-profit organisations, citizens' representatives;

Consortium roles

- Main Applicant
- Co-applicants
- Co-operation Partners



IMPORTANT!

Please be well aware that not every Funding Agency in every country may fund every organisation type. Organisation types that can be funded may also differ for research types, pathways and even topics in one country or region. When building a consortium pay attention to table 1 in Annex A and the information listed for each country in the Annex A.



Transnational eligibility criteria

The DUT Call 2023 requires project consortia from at least

- three independent legal entities, applying for funding from
- three different countries that have Funding Agencies participating in the call;
- two eligible Applicants within the consortium must be from different EU Member States or Associated Countries eligible for EC co-funding for this Call
- Each consortium must include at least one urban government authority partner, either as a Main Applicant, Co-applicant or Cooperation Partner, depending on the national/regional eligibility criteria.

The whole list of transnational eligibility criteria is available in the Call text.



Other criteria

- Project proposal must be written in English and must respect the template form
- Maximum project duration is 36 months
- Project proposal must be submitted on the UEFISCDI electronic submission system before the corresponding deadlines


The total budget of RESTART 2016, 2020 Programmos is 215,505,000 Euros.



- Full proposal stage (Stage 2): submitted by an invited project consortium to the same Call Module

3 levels of eligibility criteria and requirements:

- Transnational eligibility criteria
- Call Module requirements
- National/regional requirements (separate submission may be needed, see Annex B)

3 evaluation criteria:

- Excellence
- Impact
- Quality and efficiency of the implementation

Evaluation and selection process

- Two-stage process:
 - pre-proposal
 - full-detailed proposal
- Evaluation by international, independent expert panel at both stages.
- Evaluation of expert panel will result in six ranking lists corresponding each to a specific Transition Pathway and ROA or IOA;
- Selection by a steering committee representing the funding agencies, based on the ranking lists and the available national/regional budgets committed to the Call.

Selection choices crucial for your project:

- Choose the most relevant transition pathway;
- R&I approach: researchoriented approach (ROA) or innovation-oriented approach (IOA)

TP	Research-oriented approach (ROA)	Innovation-oriented approach (IOA)
PED TP	Ranking list PED + ROA	Ranking list PED + IOA
15minC TP	Ranking list 15mC + ROA	Ranking list 15mC + IOA
CUE TP	Ranking list CUE + ROA	Ranking list CUE + IOA

Evaluation criteria

The pre-proposals and full proposals will be assessed by a **panel of experts** against the three standard **sets of criteria**:

- 1) Excellence and Intellectual Merit
- 2) Impact and User Engagement
- 3) Quality and Efficiency of project implementation


Evaluation scores over 5 will be awarded for each of the three criteria.

Criteria are decomposed into **sub-criteria**:

- > Some sub-criteria will not be assessed in Stage 1, but only in Stage 2.
- > Some sub-criteria are specific to the research-oriented or to the innovation-approach.



Parts of the proposal





Submission

Proposals need to be submitted to both

→ the CET/DUT submission platform

(from the Coordinator of the transnational consortium)

→ RIF's IRIS platform

(from the Coordinator of the Cypriot consortium)



If the proposal is not submitted to both platforms it will be deemed ineligible.
