European Partnerships – Key Digital Technologies (KDT) Programme (1)

- National Funding Scheme for the support of local Organisations wishing to participate in Projects of the KDT Partnership
- ☐ Aims to:
 - ✓ Encourage local enterprises and other organisations to participate in transnational research and development projects in the Electronic Components and Systems areas
 - ✓ Promote the networking and collaboration between Cypriot and foreign
 organisations through the participation in transnational industrial research and
 development projects
- ☐ Budget: **€ 3.000.000** for 2021-2027









European Partnerships – Key Digital Technologies (KDT) Programme (2)

- ☐ Five Calls for Proposals for 2022
- ☐ To support the participation of local organisation in the respective Joint Calls for Proposals of the KDT Partnership
- Budget: € 3.000.000 (Covering all Calls)
- **☐** Funding per Project (for Cypriot partners): € 500.000
- ☐ Announcement Date: 21 July 2022
- **□** Deadlines:
 - ✓ 21 September 2022, 17.00 (Brussels Time) Submission to the EU
 - ✓ 22 September 2022, 13:00 (Local Time) Submission to the RIF

Specific Conditions for Participation

- ☐ Host Organisation (of the Cypriot Consortium) could be an Enterprise, a Research
 ☐ Organisation or an Other Private or Public Organisation
 ☐ Research Organisations. Enterprises and Other Private or Public Organisations
- Research Organisations, Enterprises and Other Private or Public Organisations can participate as Partner Organisations (in the Cypriot Consortium)
- Maximum number of organisations in the Cypriot Consortium should be between one to three (1-3)
- Participation of Large Enterprises is only permitted when an SME is also participating in the Cypriot Consortium.
- Participation of startups is not allowed except for those with marketable products/services, with a record for sales and turnover and audited financial statements for at least two (2) years.

☐ For Innovation Actions:

- > The participation of an **SME in the Cypriot Consortium is obligatory**
- ➤ At least 30% of the Cypriot consortium's participants budget should be allocated to Enterprises









- ☐ Eligible Activities:
 - For Innovation Actions: Experimental Activities
 - For Research and Innovation Actions: Industrial Research
- ☐ Eligible Costs:
 - Personnel costs *
 - Instruments and Equipment Costs (Depreciation)
 - Costs for External Services
 - Costs for Travelling Abroad
 - Consumables
 - Other Specific Costs
 - Overheads (Up to 20% of Direct Costs)



^{*} All beneficiaries that have not previously participated in the RESTART 2026-2020 Programmes, should make use of the simplified cost Method «Standard Scales of Unit Costs» for the calculation of personnel costs.

Proposal Submission

for Horizon Europe Programme.

- ☐ Transnational Proposal is submitted electronically (on-line application form) by the Transnational Project Coordinator, through the EU Funding and Tenders Platform
- ☐ Coordinator of the Cypriot Consortium should also submit a Proposal to RIF through IRIS. Project Coordinator and all local participating organizations of the Cypriot Consortium, should register in advance on IRIS
- Proposal submitted to the RIF includes only general information regarding the Transnational Proposal and the Consortium and detailed budget for each partner participating in the Cypriot Consortium
- Proposal Parts:
 - ✓ Part A General Information & Budget
 - ✓ **Audited Financial Statements** of the HO for the previous financial year or the year preceding it. Organisations undergone a financial viability check by the RIF in the frame of previous contract preparation, with valid financial viability check results, are exempted (private)
 - ✓ **Official Proof** for the registration of updated data of participants' ultimate beneficial owners in the Competent National Registry / Archive (where applicable)
 - ✓ <u>Declaration</u> regarding the ultimate beneficial owners of applicants in the Call of the funding Programme (where applicable)





Evaluation and Selection Procedure



- «Key Digital Technologies» Partnership applies its own central procedures and regulations for submission and evaluation of proposals and selection of projects, which are described in the Work Programme and relevant guidelines
- ☐ Funding decision is taken centrally by all the participating countries in the

 Programme, based amongst other, on the results of the scientific evaluation, the

 available EU and National budgets, and the priority focus topics
- ☐ Information on the **outcome of the Evaluation**: Maximum 5 months from submission deadline
- ☐ Indicative date for the **signing of Grant Agreements**: Maximum 8 months from submission deadline


